MINUTES

The Putnam County Planning Commission held its regular meeting on Tuesday, July 21, 2020 at the Putnam County Courthouse, Second Floor Room, 202.

STATUS OF TEXT AMENDMENT PROPOSALS

Text Amendments that were discussed and unanimously approved during the Teleconference Planning Commission Meeting on April 21, 2020 were denied by a 2-1 vote at the Putnam County Commission meeting. It was noted that the County Commission Meeting was under a time restraint and that Text Amendment votes were affected. It was suggested that staff should speak with Commissioner Skidmore and Brian Ellis regarding the Text Amendment Proposals. After a short discussion, it was decided to revisit the Text Amendment Proposals at a later date and possibly call for a December meeting.

TIME ALLOWED FOR DEVELOPMENT PERMIT COMPLETION

Ron Foster requested a discussion regarding the time allowed for the completion of a project requiring a development permit. The time allowed varies according to the type of approval. Different situations with approvals were discussed by several members of the commission. A suggestion was made to decide on a time frame for a re-evaluation to decide if a project is moving along as it should or if there are extenuating circumstances that would call for an extension or a rejection. Members decided to discuss this item at a future meeting.
