- 18) show distance of the proposed salvage yard to an existing public or private school or land owned by the Putnam County Board of Education
- 19) show distance of the proposed salvage yard to an existing public or private playground or recreation area
- 20) show distance of the proposed salvage yard to any year-round water body or course
- 21) label any sensitive areas abutting the property
- 22) designate the parking area
- 23) state composition of parking area
- 24) state location of nearest fire hydrant
- 25) show location(s) and width of the means of egress and ingress to the site from the highway

10. Submit evidence that an application has been submitted for a required salvage permit from the State of West Virginia.
11. Submit an approved encroachment permit from the West Virginia Division of Highways.
12. Submit a Sediment Control Plan approved by either the WV Soil Conservation Service or the Department of Environmental Protection.
13. Submit documentation that the County Fire Coordinator has been notified of a proposed salvage yard that includes the name and address.
14. Submit a list of all property owners within 500 feet of the proposed salvage yard and include the tax map and parcel number for each of those properties.
15. Submit stamped envelopes addressed to the property owners within 500 feet of the proposed salvage yard
16. Submit name and address of homeowner association president if one of the properties located within 500 feet of the proposed salvage yard is in a subdivision.
